Client Responsibilities Prior to Arrival at Clear Creek Performance Horses, LLC:

- * Your horse must vaccinated and boosted by your veterinarian at least 2 weeks prior to arrival.
- * It is strongly recommended that your horses teeth be checked, wolf teeth pulled and teeth floated if needed.
- * Horse must be in general good health with no known transmittable diseases.
- * A suitable blanket (seasonal) must be provided for your horse or one will be purchased and charged to client. These blankets will be laundered/repaired as needed and charged out on your monthly statement.
- * CCPH, LLC. recommends health and mortality insurance on your horse. CCPH, LLC. will not be held responsible for any injury or death of horse while in training or living on the premises.

Board and Training Terms:

- * Training Rate per month is \$1600. All accounts are billed on a monthly basis, due and payable upon receipt for each training month.
- * Short term horses (3 months or less) are due and payable at the beginning of each month.
- * **30 days notice** is required to withdraw any horse from training. Client is responsible for the full training fee if horse is withdrawn without 30 days notice.
- * Veterinarian services and supplies are managed by CCPH, LLC but are the sole responsibility of the client and will be billed directly to the owner of the horse or

put on your monthly statement.

- *Farrier services will be paid by CCPH, LLC. and then billed to the client on your monthly statement. Shoeing charges billed per individual horses needs.
- * Horses will be wormed by CCPH, LLC. every other month and billed to client.
- * All accounts must be paid in full before horses(s) are removed from training facility.
- * 1 Lesson per week is included at no extra charge for clients with horses currently in training with Clear Creek Performance Horses, LLC. If lessons exceed 1x/week, they will be billed on your monthly statement.
- * Haul In lessons with your own horse: Flag \$50 ~ Dry \$75 ~ Cattle \$100

Rehabilitation and Soundness Maintenance:

- * Bandaging, wrapping, and sweating of the legs \$ extra
- * Castration after-care by cold hosing and hand walking/lunging- No extra charge
- * Horses off for lameness and in rehabilitation or sick will be billed the normal monthly rate.
- * Adequan or Legend, Gut X, Osteo Max, Probiotics, EPM Prevention and management meds or any other supplements given by CCPH, LLC as needed and/or by recommendation of veterinarian and will be charged on your monthly statement at current market value.

Showing:

- * Day fee of \$40/horse/day will be charged while at shows for horses currently in training.
- * *Hauling is charged at \$.65/mile and will be billed on your monthly statement.
- * Accommodations and other show related expenses will be split between clients at show and billed on your monthly statement.
- * Entries, Stabling, shavings, tack stalls, practice pen works and entry fees will be paid for by CCPH, LLC. and billed to the client on your monthly statement.

- * 30% of any monies won by Cayley Wilson or any persons working for CCPH, LLC. will be charged on your monthly statement.
- * Horses shown by CCPH, LLC that are Not currently in training will be charged a \$100/horse/day, plus 30% of any monies won by CCPH, LLC as well as a portion of the accommodation and travel expenses incurred.
- * Horse or Rider preparation and lessons of horses that are Not currently in training will be charged \$100/horse/day as well as a portion of the accommodation and travel expenses incurred.
- * When a turn back horse (helping horse in the herd) is hauled to a show, the cost of the stabling, bedding, health and coggins will be split amongst clients who have horses attending the show.
